The territorial lands in the Windsor area, which sits on the traditional territory of the Three Fires Confederacy of First Nations, which includes the Ojibwa, the Odawa, and the Potawatomie. We respect the longstanding relationships with First Nations people in this place in the 100-mile Windsor-Essex peninsula and the straits – les détroits – of Detroit.

London Area— the traditional **territory** of the Anishinaabeg, Haudenosaunee, Attawandaron (Neutral), and Wendat peoples. This **territory** is covered by the Upper Canada Treaties. ... North Bay — the **land on** which we gather is the traditional **territory** of the Nipissing First Nation Anishnabe.
