Spring Meeting: Coming up in a week and a half, May 12 and 13. Keynote speakers will be motivating. We have had a few Expressions of Interest.

2. Congregational Support Minister Report: Lynne Allin

Tri-Regional Property meeting May 23 at 7:00 pm: Will work on getting it recorded to share. Like Kindred Works, Trinity Center is very aggressive and slick at selling their services. We will find out if it is in alignment with our goals. Who owns the property, how much are

the costs? Supposedly into a non-profit partnership. A loss of resources, but into what? Church would be given a lease-back into some space. If church ceases to exist then they own the entire property. Other groups are also looking for church properties to develop. Kindred Works is about building affordable housing on church properties, as opposed to community hubs with for-profit groups.

We need ideas to help communities of faith find options and resources. We will start brainstorming.

Pastoral Charge Supervisor Training: This will become available soon, will look at discussing payment at the Fall Gathering, not as a vote. The training portion will be on Churchx soon.

New Vision Memorial Service for Jim Evans: we have sent our prayers and flowers. Lynne attended and read a message from President Jane Van Patter. Matthew Penny will be appointed as supply minister.

Newsletter: Companion for closing churches request had one volunteer. How do we embody support with our presence?

Collaborative Ministry Update: Andi and I are meeting with Kent group. Villages is meeting as well to put together more resources.

Kerwood and Zion United Churches Update: were thinking of disbanding and are now going to look at amalgamation. Zion is planning on amalgamating with Thorndale. There is conversation with Browns United Church about collaboration. Otterville is collaborating with Avondale, and are having problems with the tenants in their manse. May need manse modernization grant at some point.

Making your Church Building a Community Asset Course being offered through TUCC led by Katja Brittain: Does this interest you? Would you prefer four 2-hour sessions over a few weeks or one with 7 hours throughout one day? Cost would be covered by ARW. This is a do-it-yourself group. \$299 as a group. Congregations would also benefit.
