**MOTION** by Mark Perry / Carey Wagner that the Congregational Support Commission of Antler River Watershed Regional Council consent to the request from Central United Church, Windsor Board of Trustees to list for sale the property known as 628 Ouellette Ave, Windsor, Ontario, PT Lot 3 Block I Plan 256: Pt Lot 4 Block I Plan 256 Parts 2 to 6, 12R6038 S/T R8268 with the following terms:

- Royal Lepage Binder Real Estate as broker;
- List price 499,900;
- Commission 5% with offer to pay co-operating brokerage a commission of 2.5%.
