Welcome and Constitute Meeting: Greg Simpson welcomed everyone to the meeting. The meeting was then constituted and opened.

Acknowledging the Land: Territorial lands are acknowledged on behalf of the Congregational Support Commission by Greg Simpson:

I know that some of you are joining us from different areas and locations, but the land that is known as Chatham-Kent today is the traditional land of the Three Fires Confederacy: the Odawa, Potawatami and Ojibwe peoples. These Indigenous Nations, also known as the Anishinaabeg and Lunaapeew, agreed to the mutual sharing of the land, with obligations and responsibilities to the environment. Throughout the years people of many nations and nationalities have been part of the creation of the world we see and know around us. Many of them were oppressed, many were not given choice or liberty over their involvement. Today we pray our thanks for the conservancy and lessons of all oppressed people in our past and renew our commitment to recognize and undo legacy injustices, listen to the stories, and build better relationships between all races and nations. Let us come before the Creating One as we offer our prayers, hear holy stories, and sing sacred songs.

Opening Worship: Judith Fayter presented worship: Let's go back to Mutual Street in Toronto on June 10, 1925. Three streams of denomination's choirs sang with the assembled congregations that came for the historic union. Church leaders from the Methodist, Congregational, Presbyterian and local Union churches offered their denominational inheritances and gifts and the ceremonies ended with the *Commemoration of the Faithful* prayer.

1) The sale of certain Real Property, the legal description of which is Part Lots 3 and 4, Block 1, Plan 256, Windsor, Parts 2 to 6, 12R-6038, Windsor, and the municipal address of which is 628 Ouellette Avenue, Windsor, pursuant to an agreement between the Trustees of Central United Church, Windsor, a congregation of The United Church of Canada, as seller, and The Church of Pentecost Canada Inc. (Windsor Branch), as buyer, dated the 13th day of May, 2023, and subject to regional council approval, the terms of which are as follows:

The Church of Pentecost Canada Inc. (Windsor Branch) as purchaser, for the sale price of \$500,000, the deposit of \$5,000, the balance due of \$495,000, subject to the buyer obtaining a new first charge / mortgage satisfactory to the buyer, with the property condition as is and including applicable provisions of the Reciprocal

Access, Utility Use and Licence Agreement of June 2007, the scheduled closing date on or before July 3, 2023.

2) The following disposition of the proceeds arising from the transaction: The net proceeds, after payment of legal and real estate fees and repayment of the \$15,000 loan from the regional council will be invested in a restricted fund to earn income to support the congregation. The congregation may consult with ARW Congregational Support Commission regarding the use of the fund for specific ministry initiatives at any time.

- 2. **Tilbury-Quinn Pastoral Charge:** Update on use of restricted Funds
 Darrel S. Moffat United Church asked for use of funds until minister's retirement, Derek
 Parry. With pulpit supply this summer will still need approximately 6,000 to cover expenses.
 This commission needs to receive their Annual Report, financial statements and a formal
 request from the board. This will give them time to explore other options.
- 3. Bryanston and Villages United Churches: update

Bryanston is having some difficulties. Bryanston has an informal agreement with Villages United Church for pulpit supply for services and have been doing this for about 10 years. This is not financially feasible ongoing. There may be amalgamation talks, a draft agreement is in place. Bryanston is also looking to sell their property.

4. **Executive Report:** Greg Simpson

Last Executive meeting was on April 12 and then Executive was at the Spring Meeting on May 12 and 13. Two staff are now permanent, Michele Petick, Website & Administration, and Krista Ford, Finance. A Recruitment Team has been struck up: Kenji Marui, Louise Hall and Mary Anne Silverthorn. Our commission could be supported better with at least two more members, one geographically near Windsor and one near the Oxford area.

5. Congregational Support Minister Report: Lynne Allin

I was at Essex United Church and they are considering options. Courtright United Church is still looking at their options – there is a lack of congregation members and a beautiful building, what do they do? Probably will be selling as there isn't enough of a community around them to explore other possibilities. Many discussions around shared/collaborative ministry in South Buxton and Kent area. South Caradoc United Church members have cleared the land where the church burned and planted flowers. The members get together a few times a year and worship, although members have joined several communities of faith nearby.

Pastoral Charge Supervisors are needed! In January 2024 PCS will be paid, will require Boundaries and Racial Justice Training. Communities of faith will pay PCS and regional council will pay mileage. Right now, we are considering pay being at \$30 an hour.

John Neff, CSC Minister at WOWRC, and I are putting together a workshop on Collaborative Ministry.

I will be on vacation at the end of June.
