## 3. Executive Report: Greg Simpson

There was a very short Executive meeting after the Tri-Regional meeting on June 15.

## 4. Tri-Regional Evaluation Report:

Was a gathering at the Regional Council office in Hamilton. This was a start in the process. Executives have yet to decide on priorities and dissemination of the reports.

# 5. Congregational Support Minister Report: Lynne Allin

Orientation meeting on July 13 at 1:00 pm for Jim Stirling, Herb deJong and Karen Tobey, a new member on the Horseshoe Falls Congregational Support Commission.

John Neff and I have the Pastoral Charge Supervisors training almost completed.

Statistics reports: many communities of faith have not submitted their stats. This can affect their assessment. And the United Church requires these for long-term planning.

Belle River Pastoral Charge to disband: Are in a pastoral charge with Woodslee, but have decided to disband. Are not interested in amalgamating. Essex United Church is without a minister. Encouraging area churches to have a discussion. Should we encourage Circuit

Riders? Many churches have 3 to 5 years left as members age and die. Centralization is not possible when members cannot drive to local churches.

Kerwood United Church in conversation with Strathroy United Church about amalgamating.

SharePoint switchover will happen this fall.
