 to the sale of certain Real Property, the legal description of which is Part Lots 3 and 4, Block 1, Plan 256, Windsor, Parts 2 to 6, 12R-6038, Windsor, and the municipal address of which is 628 Ouellette Avenue, Windsor, pursuant to an agreement between the Trustees of Central United Church, Windsor, a congregation of The United Church of Canada, as seller, and Chris Kotevski in trust for a company to be incorporated, as buyer, dated the 11th day of August, 2023, and subject to regional council approval, the terms of which are as follows:

Chris Kotevski in trust for a company to be incorporated, as buyer, for the sale price of \$365,000, the deposit of \$20,000, the balance due of \$345,000, subject to a due diligence period of 60 days after acceptance, with the property condition as is and including information about the Reciprocal Access, Utility Use and Licence Agreement of June 1, 2007, the scheduled closing date on or before 30 days after removal of all conditions.

The net proceeds, after payment of legal and real estate fees and repayment of the \$15,000 loan from the regional council will be invested in a restricted fund to earn income to support the congregation.
