### 5. Reports

Pastoral Relations Minister: Micol Cottrell

**Updates** 

- Policy updates from WOWRC expanding the VAM policy to include retired DLMs.
  Question: is this something that ARWRC HRC wishes to do?
  - Notes: This does not change the Manual categorization of retired DLMs as "lay people retired from Designated Lay Ministry," as ministry personnel as this is beyond

the scope of the regional council's work. In turn, this does not place retired DLMs who are VAMs under the oversight and discipline of the Office of Vocation.

- Lay commission members will have received invitations to ChurchHub. The reason for this is that the commissions are shifting their work from Dropbox to SharePoint. This is because SharePoint is already part of the Microsoft product that is already being paid for whereas Dropbox is an additional cost. There will be a presentation on this at the Orientation Day.
- The fall Orientation Day for Antler River Watershed Regional Council is on October 11.
  For those who are unable to attend in person there will be an option to Zoom in. The commissions will be meeting in the afternoon.
- Antler River Watershed Regional Council Fall Gathering will be entirely online Friday,

# Personal goal this fall

O Having been in this position for a year, part of my five-year plan includes focusing my work with the commissions on supporting you to look at clarifying core vision, work and goals and expanding proactive work of supporting pastoral relationships, e.g., workshops.
