Peer Groups have been formed. Have a good-sized group. Leaders arranged. It will affect our budget a little as three new facilitators will be in-training.

Licensed Lay Worship Leader Resource Team: Mary Anne Silverthorn

A Day Away event is now scheduled for April 27, 2024. The budget line last approved up to \$5,000. Now we meet every other month, our next planning meeting is in November. Will look at presbytery LLWLs becoming regional council LLWLs.

Executive Committee Report: Louise Hall

More personal connections with members are needed for succession planning. Volunteer recruitment positions. Diane Skomash, Executive member, and Mary Anne Silverthorn ... so far are the volunteer recruiters.

Louise interviewed a new person, ministry personnel, for the HR Commission. May take liaison training. Louise's recommendation to Executive was to have this person start in January 2024. People do not have to have a background in HR Commission work, but interest is needed. Any general reference? Skill and information building can be mentored by current commission members.

4. New Business

Suburban Pastoral Charge, Talbotville

What is the process to call a full-time minister serving as supply minister? Need some clarity around the process moving forward. Had a minister for 19 years and their third supply ending in March 2024.

Should this be discussed first or has it been decided already? If supply they want as permanent, how do they feel time is an issue. Are all being consulted? A full search process has intrinsic value.

Why do they have to go through the search process, e.g., Living Faith Story, etc. Once it is approved by CSC, is it done? Do we require them to post it on ChurchHub or not? Position Description not needed for supply. Faith Profile needed for permanent position. Position description and congregational meeting are required.

Are they required to interview others, if wanting their supply minister? Why can't they jump a few steps if they already know who they want and the supply wants to stay. Permanent Position Description is a must. Need to do an interview, references and negotiations with a liaison present? At congregational meeting need to say decided that they would not post the Position Description on ChurchHub.

Let's work on Best Practices to Hire Your Supply Minister for a Permanent Position. What questions might be asked for long-term position that are not for short-term positions.
